4. PHYSICAL AND SAFETY DATA Fluorescent marker containing a pigmented universal water-based ink and pastel marker with water-based ink. Robust, chisel nib with micro-capillary action for a variety of line-widths. Material of the barrel PP and thermoplastic elastomer. When stored and used properly, no hazardous reactions can be expected. In case of fire, carbon monoxide (CO), carbon dioxide (CO ₂) and with some colors nitric oxides (NO _x) will be set free as thermal decomposition products. When not used properly, some colors may stain the skin, mucous membranes or clothing and fabrics. In some materials, the stain might be permanent. In case of contact with the eyes, rinse out open eye thoroughly under running water for several minutes. If complaints persist, contact an ophthalmologist. If recycling is not possible, the writing instruments may be added to the household waste in small quantities. Only small quantities of colorants are contained in the inks. They are, however, very durable- on account of their intended use and therefore biodegradability in normal conditions in sewage works or in surface waters is difficult. They can, however, be sufficiently adsorbed in the activated sludge and eliminated from the water.
