4.1 Description of first aid measures

Eye	If in eyes, hold eyelids apart and flush continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre, a doctor, or for at least 15 minutes. Due to product form and nature of use, exposure is considered unlikely.
Inhalation	If inhaled, remove from contaminated area. Apply artificial respiration if not breathing. Due to product form and nature of use, exposure is considered unlikely.
